- Full court games.
- Teams of 5 to 8 players.
- Two 18 minute halves. The clock will run continuously for the first 16 minutes. The clock will stop on all whistles during the last 2 minutes of each half. (If a team has a 20 or more point lead at any time during the last 2 minutes of the 2nd half, the clock will run continuously from that point until the end of the game).
- Overtime: if score is tied after regulation game time, an additional 2 minutes will be added to the game.
- Subs can enter the game on any dead ball situation. (Timeouts and official stoppage).
- 2 technical fouls will result in disqualification from the league.
- 6 fouls in a game will result in removal from the remainder of the game.
- Any clarifications of rules will be addressed before the 1st game.
